Grand Jury Criticizes Sunnyvale City Council / City Manager

The County Civil Grand Jury released a report of their investigation into the appointment of an interim member to the Sunnyvale City Council. Mr. Otto Lee was called for active military duty. Some remaining Council members appointed Mr. Dean Chu, one of their former colleagues to the salaried position. The Grand Jury found the City Council violated California's Open Meetings Law by failing to give proper notice to Sunnyvale residents. The report also states that Sunnyvale's City Council failed to open up a selection process to multiple candidates, and that the City Manager failed to properly investigate and disclose the full cost of appointing Mr. Chu, whose appointment qualified him for lifetime benefits, which will cost Sunnyvale taxpayers \$4,035 annually. The city also provided Otto Lee with an \$18,000 medical benefit, which is not available to other city employees. Otto Lee also failed to submit a copy of his military orders, violating Sunnyvale's Administrative Policy. The Grand Jury's report is at:

Columbia Neighborhood Center (CNC) Expansion News

The CNC expansion is finally underway. Portable buildings for staff and the MayView Health Clinic have been set up in the parking lot, and services will be provided there. The expansion will provide more space for the clinic, and additional office space for staff and partners in CNC, including counselors who work with students at Columbia Middle School and their families. It will also include a large conference room that can be divided into two meeting spaces. Construction will take almost two years to complete.
